Brief Service Worker - GMHOT 1 Part-time Contract until July 30, 2021 - Sarnia site

At CMHA, our vision is to have mentally healthy people in a healthy society. As a leader and champion for mental health, CMHA Lambton Kent provides services and facilitates access to the resources people require to maintain and improve mental health. Our efforts promote community integration, build resilience, and support recovery from mental illness.

This position is responsible for providing comprehensive bio-psychosocial assessments for individuals referred to the Specialized Geriatric Team. The incumbent will gather collateral information from family or caregivers and in coordination with the multidisciplinary team present to the psychiatrist their findings to assist in the development of recommendations and treatment planning. The incumbent will engage the client and families, providing education and support to them through the assessment and treatment process.

Reporting to the Manager of Integrated Client Services, the incumbent will be responsible for the following functions:

- Conducting and completing detailed InterRAI assessment and where required a health assessment and gathering collateral information for individuals referred;
- Complete standardized assessments that may be required to determine services;
- Liaising, when appropriate, with other formal care givers/support providers who are involved with clients to collect collateral information, to ensure continuity of care using a least-intrusive approach;
- Providing crisis prevention and intervention planning with the hope of preventing a relapse and/or hospitalization;
- Assisting individuals in prioritizing needs/areas of consideration and to develop shortterm plans to address these priorities;
- Communicating and coordinating relevant information with Agency staff; collaborating with the team for treatment planning;

Qualifications:

- Post-secondary degree in Social Work from an accredited university with current registration with the OCSWSSW; a Registered Nurse or Registered Practical Nurse with current registration with the College of Nurses of Ontario (preferably with Canadian Certification in Psychiatric/Mental Health Nursing), a Post-secondary degree in a Relevant Discipline with current registration with the CACCF or other professional college/association deemed relevant by agencyExperience and knowledge of serious mental illnesses, addictions and other mental health related conditions, usually gained by a minimum of 2 years of experience in working with this population;
- The candidate will work with other professionals using strong problem solving and communication skills;
- A valid driver's license, and use of a vehicle, which will be used in conducting agency business, is required.

Skills required:

- must have experience in assessing older adults;
- extensive knowledge of age-related conditions;
- crisis or suicide intervention training is an asset;
- CPR training;
- must have an extensive knowledge of serious mental illness;
- extensive knowledge of the Mental Health Act, as well as relevant legislation specific to individuals with a serious mental illness;
- extensive knowledge of the support/treatment services network in the Municipality of Chatham-Kent and Lambton County;
- extremely well-developed written and verbal communication skills;
- excellent organizational and time management skills; and
- working knowledge of computers with skill in the use of email and Microsoft Office.

Hours of Work: 21 hours/week. Flexible hours are required to meet the position requirements.
